3. **In case of arrival into UAE through Sharjah, an additional fee of US\$ 50 per visa will be charged.**
4. **Visa fees are payable in full in advance and if rejected by immigration authorities, the amount is non – refundable.**
5. **Hotel accommodation is MANDATORY in order to proceed with visa application. Kindly ensure that you have a hotel booking or we will not be able to proceed with your application.**
6. **5% VAT will be charged additional on all the above services, as per UAE government.**

Nationals of the following Countries do not require Visas to enter the UAE and are automatically granted a visa upon arrival (no need to apply).

However, we strongly recommend that you check your status with your embassy.

Andorra, Australia, Austria, Bahrain, Belgium, Brunei, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, Iceland, Ireland, Italy, Japan, Kuwait, Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Monaco, Netherlands, New Zealand, Norway, Oman, Poland, Portugal, Romania, Qatar, San Marino, Saudi Arabia, Singapore, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, United Kingdom, United States of America and Vatican.
